<b>LEGAL BASIS/MANDATE:</b>				
<i>Activity 13(S1) of the Programme of Work 2014-2015, as adopted by the decisions BC-11/26, RC-6/16 and SC-6/30</i>				
<b>BACKGROUND INFORMATION:</b>				
<p>The Rotterdam Convention has developed a resource kit which organizes, in a user friendly manner, existing material such as guidance documents, manuals, handbooks, etc, thus providing a comprehensive source of information on the Convention intended to assist Parties in its ratification and implementation. Under the Basel and Stockholm Conventions, available tools and publications are not organized in such a user-friendly manner. A wealth of training tools and material has been developed in the past by the individual secretariats, thus this is a unique opportunity to combine them with a common approach and provide to the end users a harmonized and complete training tool. Thus, this proposal aims at building upon the existing Resource Kit under the Rotterdam Convention by including new and existing tools and publications into an integrated Resource Kit for the Basel, Rotterdam and Stockholm Conventions to be available online. The information materials organized under the resource kit will be regularly revised against the new needs assessments and where appropriate new material will be proposed and developed.</p>
